- ➤ to introduce a system of paying the turnover tax to newly established business entities in "difficult" districts at a rate of 1 percent, and land tax from legal entities, taxes on the property of legal entities at a rate of 1 percent;
- inclusion of all mandatory requirements related to entrepreneurship in a single electronic register and revision of repetitive and obsolete mandatory requirements;
- > simplification of procedures for obtaining licenses and other permitting documents;
- reducing state participation in the economy and opening a wide path for the private sector;
- > every year, developing development programs in the regions, with a thorough study of the problems and opportunities of all districts and cities;

- ➤ development of "roadmaps" for the development of neighborhoods by district (city) mayor's assistants and youth leaders on the issues of developing entrepreneurship in neighborhoods, ensuring population employment, and reducing poverty;
- establishing "Innovation and Technology Centers" in each district and providing practical assistance to entrepreneurs;
- > annual "Open Dialogue" of the President of the Republic of Uzbekistan with entrepreneurs;
- ➤ Establishment of 200 new industrial zones in the regions and development of the system of business incubators.
