The objectives of the "Uzbekistan-2030" strategy to provide our people with high-quality and nutritious food and to take measures to provide the population with agricultural products . In particular,



Agriculture Organization of the United Nations (FAO) today faces the ambitious task of transforming global agri-food systems to feed a growing population while protecting against adverse environmental impacts. called for more public and private investment.

Food security is a priority for Uzbekistan , and agriculture also plays a crucial role in the country's economic development. The government urged the villagers to actively plant and grow agricultural products on their farms. A sustainable water supply is essential to ensure food security for the population, while ensuring the economic viability of agriculture. If we look at the regions, about 50 % of the gross domestic product of Khorezm region is supported by agricultural production, 60% of the labor force of the region is **employed** in this field. The availability of irrigation water is important for the agricultural sector and improves the regional economy and population well-being.

"Uzbekistan is a net importer of essential products such as grain, vegetables and sugar, and about **40 percent of** the country's food supply comes from the Black Sea region. Following the global consequences of the war in Ukraine, including the increase in the prices of food and raw materials, food security has become a major concern for Uzbekistan," said the press release of the OPEC International Development Fund. In June 2022, the OPEC fund announced its \$ 1 billion Food Security Action Plan for 2022-2025, which will provide financing for imports of key commodities, thereby helping partner countries to will help ensure sustainable food supply in the medium and long term. The fund provides grants and loans to the public and private sectors of developing countries most affected by the war in Ukraine.

**Analysis** . Today, the food industry has become a huge industry that is constantly being produced on a global scale. The food industry consists of a global network of manufacturers, wholesalers, distributors and retailers that meet the ever-increasing demand for food products around the world.

Uzbekistan is currently seeking to increase the production and export of food products with high added value. Given the current shortage of capacity in the country's food processing industry, there is considerable scope for growth. Only 15% of the 20 million tons of fruits and vegetables produced annually are processed for longer storage, while 30% are lost due to insufficient storage and processing capacity. Only 16 percent of meat and milk is processed.

In Uzbekistan, by 2026, the goal is to increase the production of food products to 7.4 million tons, to increase the processing of milk (32 percent), meat (25 percent), and fruits and vegetables (28 percent). The list of 676 types of technological equipment (including several models of food processing equipment) exempted from customs duty and value added tax upon importation into the republic by the government decision of June 4, 2021. As of August 2023, the existing cold storage capacity was 1.5 million tons, which was only 7% of the total volume of cultivated products. The government plans to <sup>3</sup>double the capacity of the country's cold storage chain by 2025. The government's current development plan envisages an increase in processing capacity to 3.4 million tons by 2030, which is 30 percent of Uzbekistan's annual harvest . In 2022, the government allocated \$140 million to banks to provide soft loans for the purchase of trucks, as well as sorting and packaging equipment, and there is an option to allocate another \$330 million. By the decision of the President on September 9, 2020, it was decided to establish the General Directorate for the Development of the Food Processing Industry under the Ministry of Agriculture . The task of this bureau is to create conditions for effective cooperation between agricultural producers and food processing enterprises, to develop a strategy for the development of the food industry of Uzbekistan, to support the establishment of the necessary trade and logistics centers, and to stimulate the export of food products. loaded.
